Dear Ms. Roberts,

At the June 4th hearing (see Tr. 6/4/12, p. 42, lines 13-18), the Applicant undertook to file with the Council before June 26th, a report concerning the alternate configuration for the proposed line on the section of right-of-way (ROW) across the Highland Ridge Golf Range owned by Mr. Richard Cheney. The Applicant is pleased to report that an agreement has been reached with Mr. Cheney. Accordingly, CL&P now proposes to construct the new line on that section of ROW as shown on the drawing enclosed with this letter (original and 20 copies provided).

This new configuration will not require any additional ROW from Mr. Cheney's neighbor or from Mr. Cheney. In essence, the line configuration uses a single monopole with vertically configured conductors at the location of structure #39. This structure will be approximately 125 feet high and will raise the conductors to a level where they will be higher than that of the existing line conductors. The remainder of the proposed line will be as originally proposed in the Application. Final details will be provided in the D&M Plan.
