Directions to Site

Site is located at 4 Dittmar Road in Redding, Connecticut.

From Hartford, New Britain, Enfield, Meriden, Wolcott, and Norfolk:

- Take Route 84 westbound to Exit 5 (Routes 53 and 39 Downtown Danbury and Bethel).
- At end of exit ramp, turn right and stay in left lane to follow Route 53 (Main Street).
- From Route 53, turn left onto Route 302 shortly after entering Bethel (look for Tan and Body Salon at intersection).
- Follow Route 302 through center of Bethel and turn right at traffic light at Citgo gas station onto Chestnut Street (bear left after making this turn to stay on Chestnut Street).
- From Chestnut Street, turn left onto Dittmar Road shortly after entering watershed area (there will be a large pond on right).
- Entrance to tower property will be on left, through a stone fence, opposite a yellow house tower will be visible (there will be large piles of logs on property).
- Access road to tower is on immediate left after turning into property.

From Milford, Stamford, and Stonington

- Take Exit 42 from Merritt Parkway to follow Route 57 northbound.
- Follow Route 57 to Route 107 and turn right onto Route 107.
- Follow Route 107 to stop sign where 107 turns right toward Putnam Park, at this stop sign, travel straight ahead to stay on Lonetown Road.
- Dittmar Road will be a short distance on right, immediately after Bartram Road.
- Entrance to tower property will be approximately 40 yards on right, through a stone fence, opposite a yellow house tower will be visible (there will be large piles of logs on property).
- Access road to tower is on immediate left after turning into property.

To Hearing from Site

Hearing will be at the Community Room at the Redding Community Center at 37 Lonetown Road in Redding.

- From the site, turn left onto Dittmar Road and left again at stop sign onto Lonetown Road
- Follow Lonetown Road for approximately 2 miles and turn right at low, small white sign for Community Center at end of split rail fence. (Turn is just before elementary school—if you pass school, you've gone too far.
- Follow road to Community Center.


To Restaurant

Dinner will be at Georgetown Saloon, 8 Main Street in Georgetown (203/544-8003).


- From Redding Community Center, return to Lonetown Road (Route 107) and turn right.
- Follow Route 107 into Georgetown.
- In Georgetown, turn left onto Route 57 from Route 107, then make a quick left onto Main Street you will see a one way street sign.
- Georgetown Saloon is a short distance on right.
