PETITION TO INTERVENE

Pursuant to General Statutes § 16-50n and Regulations of Connecticut State Agencies § 16-50j-15a, T-Mobile Northeast LLC ("T-Mobile") hereby requests permission of the Siting Council ("Council") to participate, as an intervenor in the application and hearing process in the above referenced Docket.

As the Council is aware, T-Mobile is a licensed provider of wireless services in Connecticut. The replacement tower proposed in Docket No. 425 would be an important component in T-Mobile's network design for Fairfield County. T-Mobile will therefore be significantly affected by this proceeding.

Finally, T-Mobile has an interest in the hearing and in the pre-hearing process, aiding the Council in evaluating the public interest and need considerations set forth in General Statutes § 16-50g. T-Mobile's expertise and experience in designing, constructing, operating and maintaining a wireless telecommunications system in the State of Connecticut in accordance with the rules and regulations of the Council, the

Public Utilities Regulatory Authority and the Federal Communications Commission, may be of benefit to the Council in considering the information presented in Docket No. 425. T-Mobile has been admitted as an intervenor in numerous prior Council dockets.

T-Mobile proposes to participate in the hearing offering oral and written testimony or evidence and filing pre-hearing interrogatories and post-hearing materials. If the facility is approved, T-Mobile intends to install antennas at the 120-foot level on the proposed 127-foot tower disguised as a pine tree and its equipment on a concrete pad near the base of the tower.

For the above-stated reasons, T-Mobile seeks permission to participate in this docket as an intervenor.
