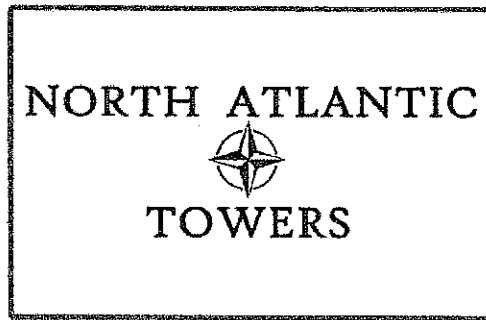

Dear Mayor Maturo:

I am writing to you in connection with the above referenced tower facility proposed for service in western East Haven along the shoreline. Please accept this letter as Florida Tower Partners, LLC, d/b/a North Atlantic Towers' commitment to allow the Town of East Haven (the "Town") to install emergency communications antennas on the above referenced tower as a public service. No rent would be charged. Should the Town have a current need for such antennas, please let us know who we may coordinate with in order to review the Town's specifications.

If there is no current need and the Town's interest is for future infrastructure, then please note that a sublease agreement would be required and would be subject to our standard terms and conditions at that time. It is our expectation that the Town could install one or two whip antennas extending above the top of the tower and place equipment in an approximately 10' by 10' area in the facility compound.
