TO: FIELD REVIEW OF FIRST SITE – Off Route 67, Roxbury (Site A)

Via Interstate 91 North or South

Proceed on I-91 towards I-691 in Meriden. Take I-691 West to I-84 West. Follow I-84 West directions on the next page.

Via Interstate 95 North or South

Take I-95 towards Bridgeport. Take Route 8 North towards Waterbury. Take I-84 West. Follow I-84 West directions on the next page.

Via Route 8 North or South

Take Route 8 towards Waterbury. Take I-84 West. Follow I-84 West directions on the next page.

Via Route 25 North (from Fairfield County)

Take Route 25 North to the Newtown Town Line. Continue on Route 25 for about 0.8 miles.

Turn right onto Route 6.

Follow Route 6 to Interstate 84.

Take I-84 East.

Take Exit 15 (Route 67) off of I-84 East.

Turn left onto Main Street North (Route 6 / Route 67).

Proceed on Route 67 for about 1.7 miles.

Turn left to stay on Route 67.

Continue on Route 67 for about 2.5 miles.

Turn right onto Bronson Mountain Road.

Continue to the cul-de-sac at the end of Bronson Mountain Road.

Via I-84 West

Proceed on I-84 West.

Take Exit 15 (Route 67) off of I-84 West.

Bear right onto Main Street North (Route 6 / Route 67).

Proceed on Route 67 for about 1.5 miles.

Turn left onto Roxbury Road (Route 67) to stay on Route 67.

Continue on Route 67 for about 2.5 miles.

Turn right onto Bronson Mountain Road.

Continue to the cul-de-sac at the end of Bronson Mountain Road.

TO: FIELD REVIEW OF SECOND SITE – 126 Transylvania Road, Roxbury (Site B)

FROM: FIRST SITE - Off Route 67, Roxbury (Site A)

Leaving Bronson Mountain Road, turn left onto Route 67 (Southbury Road).

Proceed on Southbury Road for about 1.4 miles.

Bear right onto Bacon Road.

Proceed on Bacon Road for about 0.4 miles until it ends.

Turn right onto Transylvania Road.

Proceed on Transylvania Road for about 0.4 miles.

The site is on the left near the applicant's sign.

TO: HEARING LOCATION – Roxbury Town Hall Meeting Room 29 North Street Roxbury, Connecticut

FROM: SECOND SITE - 126 Transylvania Road, Roxbury (Site B)

Turn right onto Transylvania Road.

Proceed on Transylvania Road for about 0.4 miles

Continue straight so Transylvania Road becomes Bacon Road.

Proceed on Bacon Road for about 0.1 miles.

Turn left onto Rucum Road.

Proceed on Rucum Road for about 0.3 miles until it ends.

Turn right onto Southbury Road (Route 67).

Proceed on Southbury Road (Route 67) for about 2.2 miles.

Turn left onto Church Street (Route 67) to stay on Route 67.

Turn right onto North Street (Route 67).

Proceed on Route 67 for about 0.3 miles.

The Town Hall is located on the left at 29 North Street.

Via Interstate 91 North or South

Proceed on I-91.

Take I-691 West to I-84 West.

Follow I-84 West directions below.

Via Interstate 95 North or South

Take I-95 towards Bridgeport.

Take Route 8 North towards Waterbury.

Take I-84 West.

Following I-84 West directions below.

Via Route 8 North or South

Take Route 8 towards Waterbury.
Take I-84 West.
Following I-84 West directions below.

Via I-84 West

Proceed on I-84 West.
Take Exit 15 (Route 67) off of I-84 West.
Bear right onto Main Street North (Route 6 / Route 67).
Proceed on Route 67 for about 1.5 miles.
Turn left onto Roxbury Road (Route 67) to stay on Route 67.
Continue on Route 67 for about 6.7 miles.
Turn left onto Church Street (Route 67) to stay on Route 67.
Turn right onto North Street (Route 67).
Proceed on North Street for about 0.3 miles.
The Town Hall is located on the left at 29 North Street.

TO RESTAURANT: Jordan's Restaurant, 900 Main Street, Southbury FROM HEARING LOCATION: Roxbury Town Hall, 29 North Street, Southbury

Turn right onto Route 67 (headed south towards Southbury).

Proceed on Route 67 for about 0.2 miles.

Bear left onto Church Street (Route 67).

Proceed on Church Street for about 0.1 miles.

Turn right onto Southbury Road (Route 67)

Proceed on Route 67 for about 4.7 miles.

Turn right onto S. Britain Road (Route 172).

Proceed on S. Britain Road for about 4.2 miles.

Turn left onto Main Street South.

Take your first left onto 900 Main Street, Southbury

Jordan's Restaurant is located at the rear of the property at the top of a hill.
