### TO FIELD REVIEW

## From Route 8 (Waterbury/Bridgeport)

Follow Route 8 to Exit 12.

From Exit follow Old Stratford Ave west. (Turn left if coming from Bridgeport – turn right if coming from Waterbury).

Take next right onto Pootatuck Place – before hotel and BP Gas. Site is on right.

#### From New Haven/Milford

Follow I-95 to Exit 38 - Merritt Parkway Connector Follow Merritt Parkway south to Exit 52, Route 8. Follow Route 8 north. See directions from Route 8 above.

#### TO CITY HALL FROM SITE

Return to Route 8 and get on Route 8 northbound.
From Route 8, take Exit 14.
At end of ramp, take right (Kneen Street).
At light, take right onto Coram Avenue.
Follow Coram Avenue 0.2 mile.
City Hall is on left. Park along Coram Ave. or Hill Street.

### **Directions to Restaurant**

From City Hall, follow Coram Avenue back to Kneen Street (light). Take left onto Kneen St. and take left onto Route 8 north ramp. From Route 8 north, take Exit 16 for Pershing Drive. At first light, take right and follow driveway on right.
