#### PRE-HEARING SUBMISSION OF THE UNITED ILLUMINATING COMPANY

The United Illuminating Company ("UI") hereby submits its response to the December 14, 2012 Hearing Procedure memorandum issued by the Connecticut Siting Council (the "Council") in preparation for the January 17, 2013 hearing before the Council on UI's application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of an electric substation to be located at 14 Old Stratford Road, Shelton, Connecticut (the "Project"):

#### I. Witnesses
