## **DIRECTIONS - DOCKET 434 – WEST HARTFORD**

**TO: FIELD REVIEW OF SITE – American School for the Deaf, 139 North Main Street, West Hartford**

### **Via Interstate 84 East or West**

Take Exit 43 (Park Road / West Hartford Center) off of I-84.

Turn left onto Park Road.

Proceed on Park Road for about 0.4 miles.

Turn right onto South Main Street.

Proceed straight for about 1.3 miles.

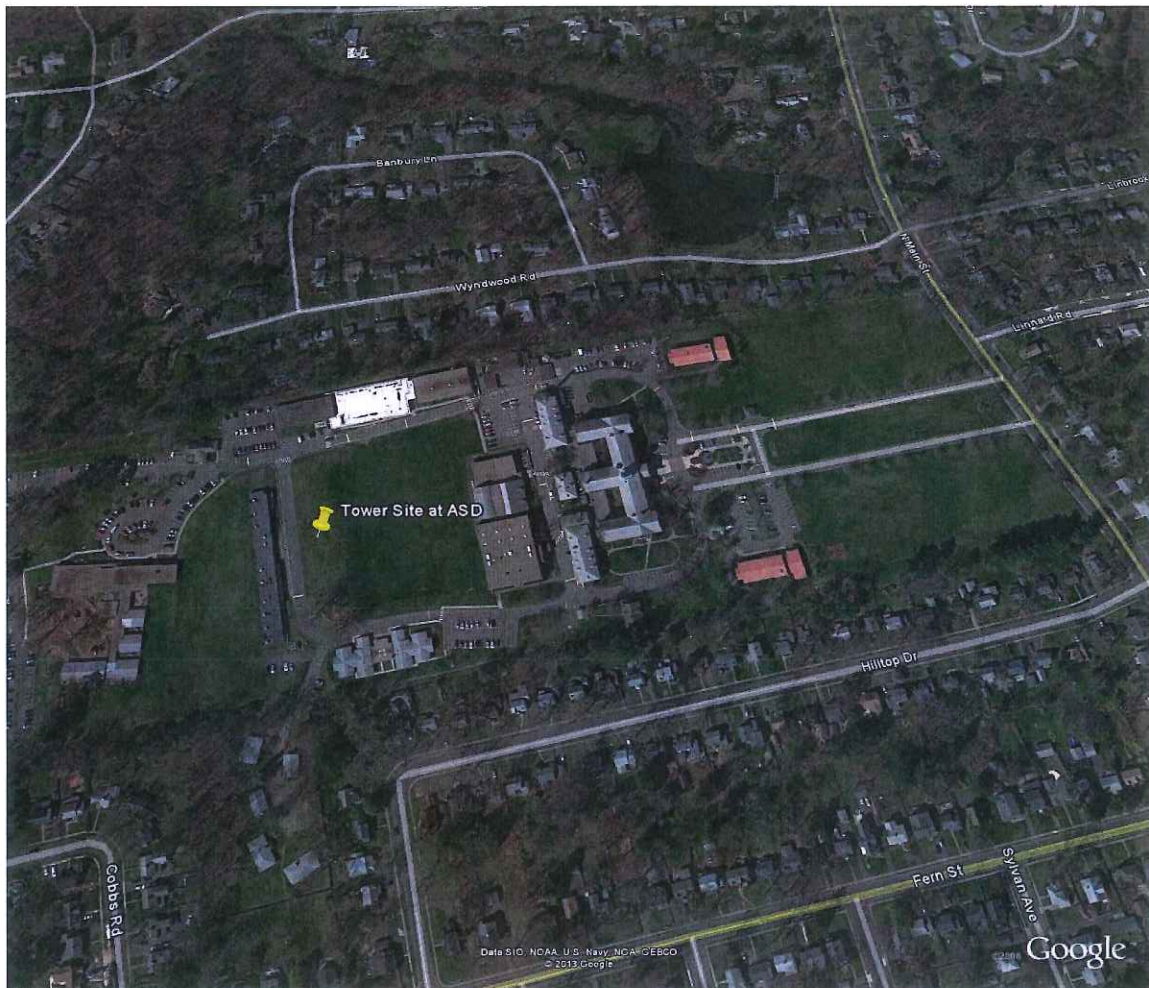
Turn left into the main entrance of American School for the Deaf.

The entrance is about 700 feet long.

At the end of the entrance, bear right to go around the building currently under construction.

Proceed straight for about 700 feet. A grass area is located on your left.

Turn left directly after the grass area, and park on that driveway.



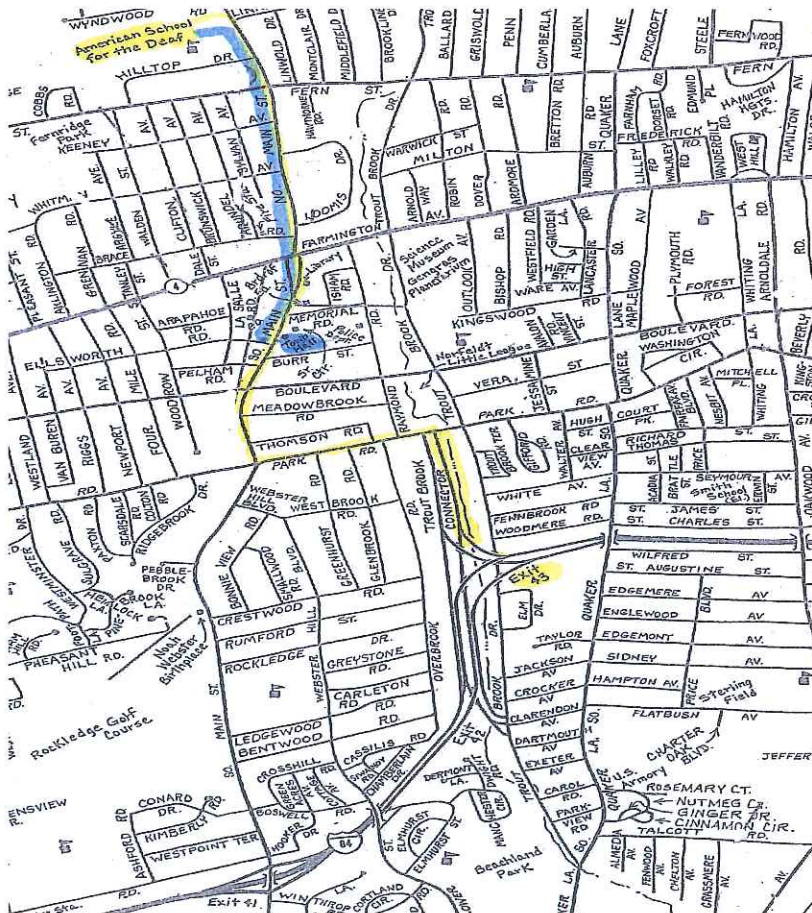
**TO: HEARING LOCATION – West Hartford Town Hall  
50 South Main Street  
West Hartford**

**FROM: SITE – American School for the Deaf, 139 North Main Street,  
West Hartford**

Turn right onto North Main Street.  
Proceed straight for about 1.0 miles.  
Turn left into the parking gate just past the West Hartford Town Hall.  
Take a parking ticket from the machine.  
Park in the parking area.  
Bring your parking pass inside the building with you so it can be validated later.

**Via Interstate 84 East or West**

Take Exit 43 (Park Road / West Hartford Center) off of I-84.  
Turn left onto Park Road.  
Proceed on Park Road for about 0.4 miles.  
Turn right onto South Main Street.  
Proceed straight for about 0.4 miles.  
Turn right into the parking gate just before the West Hartford Town Hall.  
Take a parking ticket from the machine.  
Park in the parking area.  
Bring your parking pass inside the building with you so it can be validated later.

**Rizzuto's Restaurant and Bar, 111 Memorial Road, West Hartford**

**FROM: HEARING LOCATION: West Hartford Town Hall, 50 South Main Street, West Hartford**

This restaurant is within walking distance from the West Hartford Town Hall.

Exiting from the front of the West Hartford Town Hall

Turn right and proceed towards the intersection of South Main Street and Memorial Road. Turn right onto Memorial Road. Proceed straight to Rizzuto's, the first restaurant on the right.

Exiting from the rear of the West Hartford Town Hall

Turn left and proceed towards Memorial Road. Turn right onto Memorial Road. Rizzuto's is the first restaurant on the right.
