NOTIFICATION PURSUANT TO C.G.S. § 16-50I(e)

Pursuant to Connecticut General Statutes § 16-50I(e), attached are materials which Cellco Partnership d/b/a Verizon Wireless (“Cellco”) is required to provide to the Siting Council (“Council”) in connection with the proposed relocation of its West Hartford West wireless telecommunications facility on property at 139 North Main Street in the Town of West Hartford, Connecticut. These materials include:

1. All materials provided to the Town of West Hartford;
2. A summary of the consultations with representatives, officials and residents from the Town of West Hartford, including any recommendations from Town officials on the proposed telecommunications facility; and
3. Copies of any and all correspondence between the Applicant and the Town of West Hartford.

A. Materials Provided to the Town of Waterford

- Technical Report dated August 17, 2012, prepared by Cellco. Copies of Cellco's Technical Report were submitted to the Council as a Bulk File Exhibit on January 18, 2013.

B. Summary of Municipal Consultations

- On July 10, 2012, Cellco representatives met with West Hartford's Town Planner, Mila Limson and Corporation Counsel Patrick Alair to discuss Cellco's need to relocate its existing West Hartford West telecommunications facility. At this meeting, Cellco introduced the clock tower option and explained the need for the new telecommunications structure.
- On August 17, 2012, Cellco representatives met with Corporation Counsel Patrick Alair, as designee for Mayor Scott Slifka to commence the ninety (90) day municipal consultation process. Cellco submitted copies of its Technical Report to Mr. Alair and discussed the Council's application process.
- On September 10, 2012, Cellco's project team made a presentation on the facility relocation proposal at a regular neighborhood meeting organized by the American School for the Deaf.
- The Town of West Hartford chose not to hold a public information meeting prior to the submission of the Cellco Application.

C. Copies of all correspondence between the Cellco and the Town of Waterford

- Cellco's Technical Report was filed with the Council on August 17, 2012.
