**DIRECTIONS TO FIELD REVIEW – BATES WOODS PARK, NEW LONDON - 2:30 P.M.**

Follow I-95 to Exit 82 (Route 85)

At end of exit, follow signs for Route 85 South. (*turn right if coming from Old Saybrook*)

Proceed to first traffic light after I-95 interchange area and take right onto Jefferson Avenue.

Follow Jefferson Avenue to traffic light.

Turn right onto Chester Street.

Continue straight at stop sign and turn left at blinking yellow light into Bates Woods Park.

Parking lot is immediately past entrance.

**DIRECTIONS TO HEARING LOCATION - New London High School, 490 Jefferson Avenue**

**from Bates Woods Park**

From park driveway, turn right onto Chester Street.

Follow to Jefferson Avenue at light.

Go right onto Jefferson Avenue.

Turn right into New London High School entrance, and bear right to parking lot.

School entrance is opposite entrance driveway.

**From I-95**

Follow I-95 to Exit 82,

Follow signs for Route 85 South.

Turn right on Jefferson Avenue.

After traffic light, turn right into New London High School and bear right to parking.

School entrance is opposite entrance drive.

**TO RESTAURANT - Illiano's, 929 Bank St, New London**

From High School, turn right onto Jefferson Avenue.

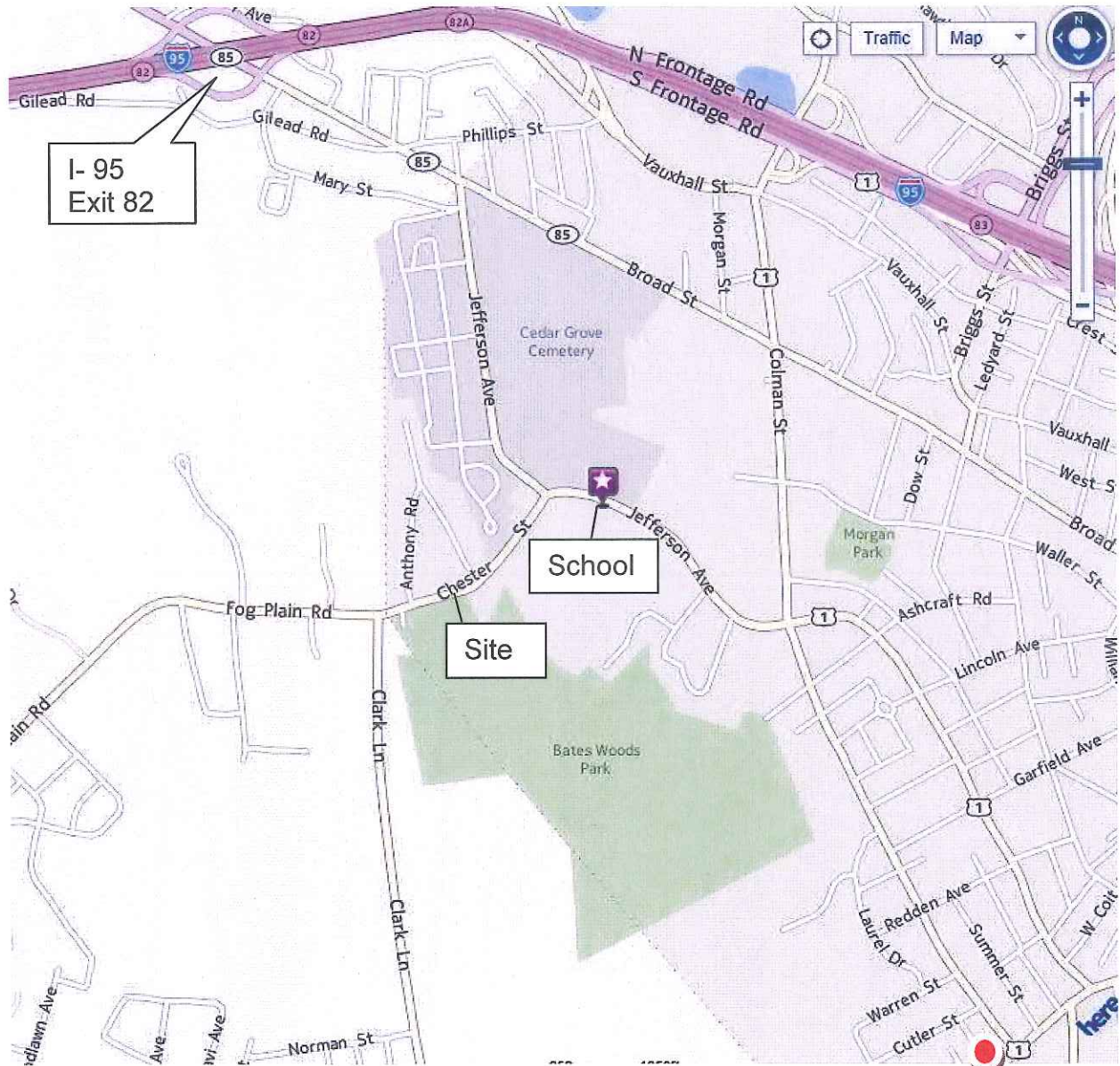
Follow Jefferson Avenue to traffic light and turn right onto Coleman Avenue.

Follow Coleman Avenue to end at Bank Street.

Turn right onto Bank Street and travel a tenth-mile.

Illiano's is on right in a red, stand-alone building.

*To return to the high school from Illiano's, pass Coleman Ave (one way) and turn left onto Jefferson Avenue and follow to school.*
