## Dear Licensee:

In April 2015, SAI Communications, Inc. (SAI) applied for, and received, a building permit (#02-15) for the construction of a new 140' high unipole telecommunications site including an  $11.5' \times 24'$  equipment shelter and generator pad at the base of the tower. SAI has informed the Department of Administrative Services (DAS) that their approved contractor, East Coast Communications, LLC, is preparing to commence construction of this telecommunications site. SAI has provided the necessary copies of plans and drawing as well as required certificates of insurance as required by the License Agreement.

Pursuant to §7(d) of the License Agreement any changes to the approved plans must be approved in writing by Licensor (DAS).

Pursuant to §7(g) of the License Agreement Licensee will notify Licensor in writing at least 10 days prior to commencing installation of any equipment. Additionally, the Office of the State Building Inspector has requested to inspect all subsurface construction prior to any closing of the construction with either gravel, concrete, asphalt or earth product.

Licensor (DAS) hereby authorizes Licensee, or Licensee's approved contractor(s) to commence with construction of the telecommunications site subject to the requirements of §7(g) of the License Agreement.
