Dear Chairman Stein and Members of the Siting Council:

On behalf of New Cingular Wireless PCS, LLC ("AT&T"), this letter is provided in furtherance of the Development and Management Plan ("D&M Plan") submitted for the facility approved in Docket 442 and in keeping with discussions with staff.

At this time please note that the structural design of the Verizon tower as submitted is now being revisited and will be revised to assure that the width of the tower does not impede the installation of Verizon's antennas and associated equipment within the tower. The final structural design of the Verizon tower will be submitted at a later date to the Council for final approval of that tower. A revised elevation view of the towers (Sheet S-4a) is included herein depicting 1) the diameter of the upper portion of the tower and 2) the bottom level of Verizon's installation as including TMA's and radio heads. The location of both towers, the associated shelters and ground-based equipment remain as proposed.

In addition, please note that as per the submitted drawing AT&T's tower mounted amplifiers ("TMAs") will be included within the tower. AT&T's remote radioheads will be installed in its shelter at ground level. Please note that both towers will be a brown color as represented at the hearings in Docket 442 and as per discussions with the State Historic Preservation Officer. Finally, please note that there is no objection to a condition of D&M approval requiring small width mesh for the planned chain link fence.
