**TO FIELD REVIEW**

**Via Route 8 Southbound (Waterbury/Shelton areas)**

Follow Route 8 South.

Take Exit 11. At end of ramp, take left onto Bridgeport Ave.

At traffic light take left onto Huntington Avenue.

After Highway interchange, take right on Merritt Blvd at traffic light.

Take left onto Commerce Drive at traffic light.

Pilot Corporation is at end of street.

**Via Route 8 Northbound (Bridgeport area)**

Follow Route 8 north to Exit 11.

At end of ramp, go right and take next right onto Merritt Blvd. at traffic light.

Take left onto Commerce Drive at traffic light.

Pilot Corporation is at end of street.

**Via Interstate 95 from New Haven and Milford areas**

Follow I-95 to Exit 38 - Milford Connector.

Follow Connector to Merritt Parkway southbound.

Take exit 52 for Route 8 northbound.

Follow Route 8 north to exit 11.

At end of ramp, go right and take next right onto Merritt Blvd. at traffic light.

Take left onto Commerce Drive at traffic light.

Pilot Corporation is at end of street.

**TO Trumbull Town Hall (Hearing)**

**From Site**

Return to Route 8 and take Route 8 southbound.

Take first exit (Exit 10) onto Merritt Parkway southbound.

Follow directions below.

**From Merritt Parkway**

Take exit 48 for Route 111.

Follow Route 111 north.

At third light, turn right onto Quality Street.

Take left into parking area for town hall (town hall to left).
