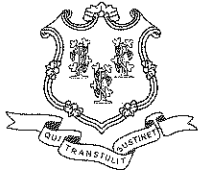
Copies of your responses shall be provided to all parties and intervenors listed on the service list, which can be found on the Council's pending proceedings website.

Pre-Hearing Questions
March 28, 2014

1. Were return receipts received for each abutting landowner identified in the application? If not, list the abutters that did not receive notice and describe any additional effort to serve notice. When was the abutter list compiled?
2. Is the wooded portion of the Pilot Corporation property immediately north of the proposed tower site designated as the Merritt Industrial Park Greenbelt? If so, what restrictions, if any, are placed on this land? Are there any public walking trails in the "greenbelt"?
3. Estimate the number of residences with year-round and "leaf-off" seasonal views of the proposed tower.
4. What would be the respective run time for Cellco's diesel generator before it would need to be refueled, assuming it is running at full load?
5. Could the proposed generator be shared by other carriers that may locate at the proposed facility? What effect would a shared generator have on the run time of the generator if at full load?
6. Identify the safety standards and/or codes by which equipment, machinery, or technology would be used or operated at the proposed facility.
7. What measures are proposed for the site to ensure physical security?
8. What is the signal strength Cellco uses to design its system? Are there different levels for voice and data systems?
9. Are all frequencies used to transmit voice and data?
10. Provide an estimate of the residential population within the proposed service area.
