

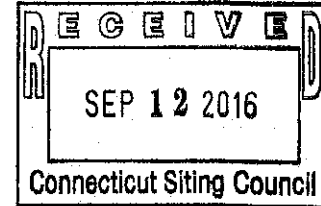

CERTIFICATE TRANSFER REQUEST

Pursuant to Section 16-50k(b) of the Connecticut General Statutes, Homeland Towers, LLC ("Homeland") hereby requests that the Connecticut Siting Council approve the transfer of the Certificate of Environmental Compatibility and Public Need in Docket 451 (the "Certificate"), from Homeland to InSite Towers Development, LLC ("InSite") (Homeland and InSite are together "the Parties").

Homeland has agreed to convey this facility to InSite. The Parties agreed upon a transfer of these certificates on or about July 1, 2016. InSite maintains its Corporate Headquarters at 1199 North Fairfax Street, Suite 700, Alexandria, VA 22314. InSite Wireless Group, LLC is one of the largest privately owned tower and wireless infrastructure companies in the United States and operates more than 1,200 telecommunications towers and sites for wireless carriers across the United States, Puerto Rico, the U.S. Virgin Islands, and Canada. InSite will own and maintain the facilities noted herein.

By countersigning this certificate transfer request and in accordance with Section 16-50k(b) of the Connecticut General Statutes, InSite agrees to comply with all terms, limitations, and conditions of the Certificate and all applicable statutes and regulations, and represents that it is technically and financially capable of owning and operating the tower facilities as approved in Docket 451. In addition, the Parties further certify that the transfer of the Certificate was not contemplated at or prior to the time the Certificate was originally issued to Homeland. InSite agrees to the timely payment of apportioned assessment charges for the noted facilities as provided under Connecticut General Statute Sec. 16-50v(b)(2).

Homeland Towers, LLC hereby requests transfer of the Certificate issued in Docket 451 to InSite Towers Development, LLC.
