Thank you for your submission. The Siting Council will take up the request to intervene at the commencement of the evidentiary session of the public hearing in Manchester at 3 PM on Tuesday, January 20, 2015.

Our hearing process consists of a 2 PM public field review of the proposed site. At 3 PM, the Siting Council will commence the evidentiary session of the public hearing at which time the request for intervenor status will be taken up, as well as begin cross examination of the applicant. The Siting Council will take a dinner break between 5 PM and 7 PM. At 7 PM, the Siting Council will commence the public comment session at which time the Siting Council will hear from members of the public who wish to voice their concerns about the proposal to the Siting Council. Sign up sheets for members of the public who wish to speak will be available during the 3 PM evidentiary session and throughout the evening. Once all interested persons have had the opportunity to speak, the Siting Council will close the public comment session and announce a date for continuation of the evidentiary session that will be held at the Siting Council office in New Britain, which will likely be to a date in March depending on the availability of a hearing room at our office.
