**Re: Proposed Development of a Telecommunications and Training Facility at 199  
Brickyard Road, Farmington, Connecticut**

Dear Ms. Eagen:

This office represents Tower Holdings, LLC (“Tower Holdings”). Tower Holdings anticipates filing an application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance and operation of a telecommunications and tower training facility at 199 Brickyard Road (“Facility”). In accordance with General Statutes § 16-50l(g), I have enclosed a technical report concerning the proposed Facility. The technical report includes information concerning the public need for the Facility, the site selection process and the potential environmental effects of the proposed Facility.

The Connecticut Siting Council has exclusive jurisdiction over the siting of telecommunications facilities. General Statutes § 16-50x. Section 16-50l(g)(1), however, requires an applicant to consult with the municipality in which the proposed facility would be located. Accordingly, the Town of Farmington (“Town”) may conduct a public information meeting to provide recommendations or comments to Tower Holdings concerning the proposed Facility.

If the Town would like to hold a public information meeting, then the Town must do so within sixty (60) days of its receipt of this filing. General Statutes § 16-50l(g)(2). Should the Town elect to conduct such a meeting, I respectfully request advance notice so Tower Holdings may satisfy any notice requirements required by statute.

If the Town would like Tower Holdings to consider any alternative sites, which may include municipal parcels, then please provide those suggested alternatives within thirty (30) days of the receipt of this filing. General Statutes § 16-50l(g)(3).
