Dear Attorney Chiocchio:

During a public meeting held on May 14, 2015 the Connecticut Siting Council (Council) acknowledged your request to withdraw the Docket No. 457 application without prejudice, dated May 4, 2015.

The Council declares this matter to no longer be pending before this agency. Please note that if you decide to present an amended application to the Council in the future for the 30 Cobblers Hill Court site that such a request will need to be submitted as a new application that must follow the applicable statutory and regulatory requirements for a new application for a certificate of environmental compatibility and public need.

Furthermore, due to the withdrawal of Docket No. 457, the Council granted an extension of time until June 30, 2016, for the above referenced temporary facility located at 375 Fan Hill Road in Monroe.

This decision is under the exclusive jurisdiction of the Council. Any additional change to this temporary facility will require explicit notice to this agency pursuant to Regulations of Connecticut State Agencies Section 16-50j-73. Such notice shall include all relevant information regarding the proposed change with cumulative worst-case modeling of radio frequency exposure at the closest point of uncontrolled access to the tower base, consistent with Federal Communications Commission, Office of Engineering and Technology, Bulletin 65.
