Re: Notice to Owners of Property Abutting the Proposed Greenwich Substation

Dear Neighbor:

This letter is to let you know that Eversource Energy is continuing its efforts to improve the electric power delivery system in Greenwich. We will be seeking approval from the Connecticut Siting Council (Council) to construct and operate a new substation and two new, underground 115-kV transmission lines that interconnect the existing Cos Cob Substation to the new, proposed substation. The name of the proposed Project is the Greenwich Substation and Line Project.

The proposed location for the new substation is 290 Railroad Avenue and the alternate proposed site is 281 Railroad Avenue. The proposed location or the alternate location for the new substation or the Cos Cob Substation property abuts your property.

This letter is to provide notice of Eversource's intent to apply to the Council on or about June 26, 2015 for a Certificate of Environmental Compatibility and Public Need for this Project. After reviewing the application for completeness the Council will conduct a local public hearing in Greenwich. If the Project is approved by the Council we anticipate starting construction in the fourth quarter of 2016, with completion in 2018. Please note this work will not interrupt electric service to homes or businesses.
