
I, Michael Libertine, being duly sworn, deposes and states that:

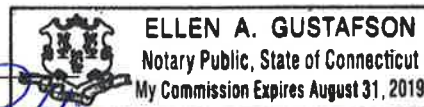
1. I am over eighteen years of age and I understand the obligations of a statement under oath.
2. I am the Director of Siting and Permitting for All-Points Technology Corp., P.C. ("APT").
