The Connecticut Siting Council (Council) is in receipt of the request for an extension of construction time in this docket dated April 20, 2018. Pursuant to Condition No. 6 of the Certificate dated December 22, 2016, the Council hereby grants your request for an extension of time in this matter until July 1, 2019 to complete the construction of this facility.

Pursuant to Condition No. 7 of the Certificate, any request for an extension to fully construct this telecommunications facility with at least one fully operational wireless telecommunications carrier shall be filed with the Council not later than 60 days prior to the expiration of this Certificate and shall be served on all parties and intervenors, as listed on the current service list and the Town. The Council acknowledges that this request for extension was lost in the mail resulting in an unforeseen delay in receipt by our office.

This extension is granted with the understanding that the Council will be notified should the Certificate Holder decide not to proceed with construction.
