RE: **DOCKET NO. 463** – American Towers, LLC and New Cingular Wireless PCS, LLC application for a Certificate of Environmental Compatibility and Public Need for the construction, maintenance, and operation of a telecommunications facility located at East Lyme Tax Assessor Parcel ID 29.0 45, 351A Boston Post Road, East Lyme, Connecticut.

DIRECTIONS – DOCKET 463: EAST LYME

TO FIELD REVIEW MEETING LOCATION – NAOMI LANE

From Hartford – Middletown Area

Follow I-91 to Route 9 south.

Follow Route 9 south to Interstate 95 north in Old Saybrook.

Follow Interstate 95 north to Exit 74 for Route 161 (Flanders Road).

Follow Route 161 north to Route 1 west (Boston Post Road).

Follow Route 1 west for approx. 1.75 miles and turn left onto Naomi Lane.

Park along street.

From Interstate 95 – New Haven/New London

Follow Interstate 95 to Exit 74 for Route 161 (Flanders Road).

Follow Route 161 north to Route 1 west (Boston Post Road).

Follow Route 1 west for approx. 1.75 miles and turn left onto Naomi Lane.

Park along street.

TO TOWN HALL – 108 Pennsylvania Avenue

From Naomi Lane

Turn right onto Route 1 (Boston Post Road).

At intersection with Route 161, turn right onto Route 161, going south.

Follow Route 161 south past I-95 and East Pattagansett Road.

Town Hall is on right, approx. 0.4 mile past SUNOCO.

From Interstate 95

Take Exit 74 for Route 161.

Follow Route 161 south past East Pattagansett Road.

Town Hall is on right, approx. 0.4 mile past SUNOCO.

To Dinner- Main Street Grille

From Town Hall, turn right onto Rt. 161 south.

Turn right onto Main Street (light) and go 100 yards.

Turn left into driveway for Main Street Grille
