DOCKET NO. 466 - The Connecticut Light & Power Company d/b/a Eversource Energy application for a Certificate of Environmental Compatibility and Public Need for the Frost Bridge to Campville 115-kilovolt (kV) electric transmission line project that traverses the municipalities of Watertown, Thomaston, Litchfield, and Harwinton, which consists of (a) construction, maintenance and operation of a new 115-kV overhead electric transmission line entirely within existing Eversource right-of-way and associated facilities extending approximately 10.4 miles between Eversource's existing Frost Bridge Substation in the Town of Watertown and existing Campville Substation in the Town of Harwinton; (b) related modifications to Frost Bridge Substation and Campville Substation; and (c) reconfiguration of a 0.4 mile segment of two existing 115-kV electric transmission lines across the Naugatuck River in the Towns of Litchfield and Harwinton within the same existing right-of-way as the new 115-kV electric transmission line.

The Connecticut Siting Council has scheduled a field review for this docket for Tuesday March 1, 2016 beginning at 1:00 p.m.

Council members will meet at the Northfield Volunteer Fire Company, 12 Knife Shop Road in Litchfield at 12:45 PM for bus transportation of the project route. Directions are enclosed.

A public hearing will be held on Tuesday, March 1, 2016, with an evidentiary session beginning at 3:30 PM and a public comment session at 6:30 PM, at the Northfield Volunteer Fire Company, Catlin Community Room, 12 Knife Shop Road, Litchfield, Connecticut.

TO FIELD REVIEW MEETING PLACE - Northfield Volunteer Fire Company, Catlin Community Room, 12 Knife Shop Road, Litchfield. 12:45 PM

FROM WATERBURY

Follow Route 8 North to Exit 38.

Turn left at end of exit ramp.

At traffic light go straight, following signs for Route 254 North.

Travel ¾ mile to traffic light.

At traffic light, turn left, following Route 254 North. (aka Northfield Road).

Follow Route 254 north for approx. 2.5 miles to traffic light.

Turn right at light onto Knife Shop Road.

Northfield Volunteer Fire Company is on right.

FROM HARTFORD

Follow I- 84 West to Route 72 East.

Follow Route 72 East through Bristol to Route 6 East.

Follow Route 6 East past Route 8 and through Thomaston center.
