Pursuant to RCSA Section 16-50j-62(b)(3) and as described in Volume 1, Section 7, of the *Development and Management (“D&M”) Plans for the Frost Bridge to Campville 115-kV Project (“Project”): D&M Plan for New 115-kV Transmission Line and Related Transmission Line Modifications* and the *D&M Plan for Modifications to the Frost Bridge Substation and Campville Substation*, The Connecticut Light and Power Company doing business as Eversource Energy (Eversource) hereby provides to the Connecticut Siting Council (Council) this Construction Progress Report for the month of September 2018.

As noted in the attached report, Eversource has now completed final restoration and stabilization of areas disturbed by Project construction. Because Project activities in the upcoming months will consist of periodic inspections to verify the effectiveness of restoration/stabilization, Eversource proposes that this be the last Monthly Construction Progress Report for the Project.

MONTHLY CONSTRUCTION PROGRESS REPORT  
SEPTEMBER 2018**

**1. NEW 115-kV TRANSMISSION LINE AND RELATED TRANSMISSION LINE MODIFICATIONS**

In mid-September, crews completed restoration and final stabilization work along the transmission line right-of-way (ROW). Eversource also continued to perform routine inspections to verify the integrity of erosion and sedimentation controls and to monitor the ROW restoration/final stabilization work.

Over the next three months, Eversource will perform monitoring to verify ROW restoration/stabilization. Crews will be on-call to address issues, if any, identified during such monitoring.

**2. MODIFICATIONS TO FROST BRIDGE AND CAMPVILLE SUBSTATIONS**

All Project modifications to both Frost Bridge and Campville substations were completed as of the end of May 2018. The landscaping installed outside the fence at Frost Bridge Substation (pursuant to Condition 2.d of the CSC's Decision and Order) is being monitored.

**3. MINOR DEVELOPMENT & MANAGMENT (D&M) PLAN CHANGES**

No minor D&M Plan changes were identified in September 2018.
