

Dear Mr. Stein:

I write to you both in my capacity as the State Representative for the 91st District and as a resident of the Town of Hamden. While being fully supportive of companies like Verizon Wireless seeking to invest in infrastructure in Connecticut, I nevertheless have grave concerns about the proposal before the Connecticut Siting Council to construct a major telecommunications tower facility in the middle of a quiet and scenic residential area of the Town.

There are four specific areas of my concern. First, the proposed tower site, as I understand it, is in an area that is zoned residential and will be much too close to homes on Country Club Road. Ms. Patricia Sorrentino, whom I understand is actively participating in your proceeding due to proximity of the proposed site to her property, and other nearby neighbors have legitimate concerns about the impact a massive cell tower facility will have on their neighborhood, property values and safety. Second, also related to safety is the fact that the proposed site will have extensive fuel storage presumably for back-up power during periods when commercial power outages occur due to weather and other conditions. The Siting Council should not allow any fuel storage in a residential neighborhood. Third, I understand the

Verizon Wireless application anticipates removing approximately thirty (30) trees for an access road and the tower compound; this amount of tree removal in a residential neighborhood is unacceptable from an ecological and scenic perspective, given the location which functions as a buffer between the neighborhood and the Laurel View Golf Course. Finally, because the area is heavily wooded, it serves as a natural habitat for animals, and children can be often found playing or exploring in the wooded area where the tower will be sited, if approved.

The Public Utility Environmental Standards Act expressly provides that "[t]he legislature finds that power generating plants and transmission lines for electricity and fuels, community antenna television towers and telecommunications towers have had a significant impact on the environment and ecology of the state of Connecticut. . . ."

Conn. Gen. Stat. § 16-50g. This provision further states "... that continued operation and development of such power plants, lines and towers, if not properly planned and controlled, could adversely affect the quality of the environment and the ecological, scenic, historic and recreational values of the state." Based on these legislative findings, I am confident that the Siting Council, upon completing its investigation and review of the record in this proceeding, will follow the principles of Section 16-50g and reject this site, without prejudice, by instructing Verizon Wireless to select another location – preferably in a commercially zoned area - for its proposed tower.

I expect to be available to offer public comment on May 2, 2017 at the public hearing, but in the meantime, please feel free to contact me if you have any questions regarding my strong opposition to the tower, compound and access road as proposed in Docket No. 471.
