**PUBLIC INFORMATION SESSION NOTICE**

Cellco Partnership d/b/a Verizon Wireless ("Cellco") will host a Public Information Session during the Coventry Planning and Zoning Commission meeting on Monday, April 10, 2017, at 7:00 PM in the Town Hall Annex, 1712 Main Street in Coventry, CT to discuss plans by Cellco to construct a wireless telecommunications facility on a portion of the Skungamaug Golf Course property, south of Folly Lane in Coventry.

Cellco proposes to construct a 140-foot monopole tower, a steel platform supporting equipment cabinets and a propane-fueled back-up generator, and a 500 gallon propane tank within a 60' x 40' fenced compound and 100' x 100' leased area. Cellco would install antennas at the top of the tower.

The telecommunications facility described above is under the exclusive jurisdiction of the Connecticut Siting Council pursuant to the provisions of Section 16-50g et seq. of the General Statutes and are subject to change.
