Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about June 28, 2017 by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility adjacent to the maintenance building at the Skungamaug Golf Course, south of Folly Lane in Coventry, Connecticut. Cellco proposes to construct a 140-foot monopole tower within a 40' x 60' fenced compound. Access to the facility will extend from Folly Lane over an existing gravel driveway. Cellco will also install a 12' x 26' steel equipment platform to support two (2) equipment cabinets and a propane-fueled back-up generator. A 500 gallon propane tank will also be installed within the fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes 16-50g et. seq.

On the day of the Siting Council's public hearing on this Application, Cellco will fly a balloon at the height of the proposed tower described above.
