NOTICE

Notice is hereby given, pursuant to Section 16-50/(b) of the Connecticut General Statutes and Section 16-50/-1(e) of the Regulations of Connecticut State Agencies of an Application to be filed with the Connecticut Siting Council (“Siting Council”) on or after September 6, 2017 by Eco-Site, Inc. (“Eco-Site”) together with T-Mobile for a certificate of environmental compatibility and public need for the construction and maintenance of a wireless telecommunications facility in Glastonbury, Connecticut.

The proposed facility is located on a parcel of land owned by Paul J. Cavanna located at 63 Woodland Street in the Town of Glastonbury and identified on the Town of Glastonbury Assessor’s Map G11, Block 7800, Lot W0002 (the “Property”). The proposed facility is located in the southwestern portion of the Property and is proposed at a height of 150’ above grade level (“AGL”). The Property is an approximately 177 acre parcel. The Facility is proposed to allow commercial wireless services in southern Glastonbury. The tower, antennas and ground equipment will be located within a 2,500 s.f. fenced equipment compound area. Vehicle and utility access to the facility would be from Woodland Street over an approximately 4,100’ access drive to the tower compound.

The location, height and other features of the proposed Facility are subject to review and potential change under provisions of the Connecticut General Statutes Sections 16-50g et. seq.

The Application explains the need, purpose and benefits of the facility and also describes the environmental impacts of the proposed facility. The facility will be available for co-location by other wireless carriers.

A balloon, representative of the proposed height of the facility, will be flown at the proposed site on the first day of the Siting Council public hearing on the Application, which will take place in the Town of Glastonbury, or such other date specified by the Siting Council and a time to be determined by the Siting Council, but anticipated to be between the hours of 12pm and 5pm.

Interested parties and residents of Glastonbury, Connecticut are invited to review the Application during normal business hours after September 6, 2017, when the application is anticipated to be filed, at the following offices:


