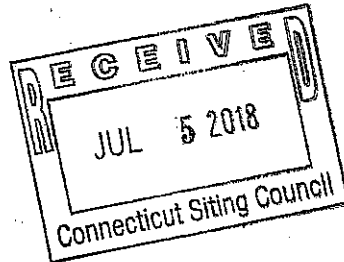

Dear Attorney Bachman:

This letter is written concerning Connecticut Siting Council Decision No. 478 approving a 150 foot communication tower for a 177± acre parcel located at 63 Woodland Street in Glastonbury. As noted in the Decision and Order, the Town of Glastonbury requested a monopine for this installation. The applicant, through Attorney Daniel Laub, was helpful by providing photo simulations of a monopine and monopole and additional information concerning location of public safety communication equipment at this location. In addition to the monopine structure, the Town had requested permission to install public safety communication equipment on this new tower.

At its meeting of Tuesday, June 26, 2018, the Glastonbury Town Council heard a presentation by Attorney Christopher Fisher of Cuddy & Feder concerning the monopole and monopine options. This information was very helpful and much appreciated.

After review, the Town Council voted to confirm its prior request for a monopine structure. I understand a final decision is subject to Siting Council action. Accordingly, I wanted to advise that the Glastonbury Town Council has formally renewed its request for a monopine structure at this location.

My thanks and appreciation to Attorneys Laub and Fisher for providing follow up information concerning the pole options and public safety communications equipment.
