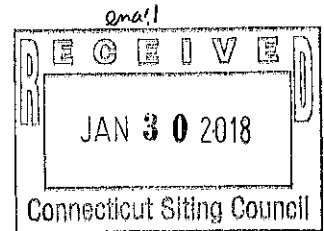

Thank you for the opportunity to provide further comments regarding Docket No. 480.

Due to the proposed project's proximity to Robertson Airport, we request that the responsible parties submit to the Federal Aviation Administration an official Notice of Proposed Construction or Alteration (Form FAA 7460-1). This is an important step to ensure that the FAA has the information necessary to evaluate if the project will have any impact to navigable airspace. The CAA takes the safety of Connecticut's airports very seriously, and we encourage the applicants to submit this information to FAA as soon as possible so this important review can proceed.
