

## LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council (“Council”) on or about February 23, 2018, by Cellco Partnership d/b/a Verizon Wireless (“Cellco” or the “Applicant”). The Application proposes the installation of a wireless telecommunications tower and related facility in the northwesterly portion of an approximately 7.78-acre parcel at 667, 665, 663 and 663R Main Street in Cromwell, Connecticut. The parcel is owned by Cromwell Concrete Products, Inc. and Libera Real Estate Holdings, LLC. Cellco proposes to construct a 120-foot monopole tower within a 50’ x 50’ fenced compound and 70’ x 75’ leased area. Access to the facility will extend from Main Street over a portion of an existing paved driveway then over a gravel driveway extension. Cellco will also install a 9’-4” x 16’ platform with a canopy roof, supporting two (2) equipment cabinets and a diesel-fueled back-up generator. The location and other features of the proposed facility, including the height of the tower, are subject to change under provisions of Conn. Gen. Stat. § 16-50g et. seq. and 47 U.S.C. § 1455e.

On the day of the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower described above. Interested parties and residents of the Town of Cromwell are invited to review the Application during normal business hours after February 23, 2018, at any of the following offices:
