- 1. In Cellco Partnership d/b/a Verizon Wireless' (Cellco) Development and Management Plan (D&M Plan) dated October 31, 2019, would the erosion and sedimentation control measures be consistent with the 2002 Connecticut Guidelines for Soil Erosion and Sediment Control per Condition 2(c) of the Decision and Order (D&O)?
- 2. Condition 2(c) of the D&O includes "water drainage and stormwater control" plans. What design measures and/or features, if any, in the D&M Plan drawings take into account water drainage/stormwater control?
- 3. Referencing the Valmont Structures calculations, page 31, Fall Zone Letter, it states, "In addition, our monopoles <u>can be designed</u> to theoretically fail at approximately 85-ft AGL by purposely over designing the pole sections below this point..." Was Cellco's approved monopole designed with this feature?
