

## PUBLIC INFORMATION MEETING NOTICE

Cellco Partnership d/b/a Verizon Wireless (“Cellco”) will host a Public Information Meeting on Wednesday, August 23, 2017, at 7:00 PM at the Town of Pomfret Senior Center, 207 Mashamoquet Road, Pomfret Center, CT to discuss plans by Cellco to construct a wireless telecommunications facility on property at 72 Ragged Hill Road in Pomfret.

At this site, Cellco proposes to construct a 150-foot monopole tower and related equipment, including a diesel-fueled back-up generator, within a 50' x 50' fenced compound. Cellco's antennas and remote radio heads would be located at the top of the tower.

The telecommunications facility described above is under the exclusive jurisdiction of the Connecticut Siting Council pursuant to the provisions of Section 16-50g et seq. of the General Statutes and are subject to change.
