

Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about July 9, 2018 by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications tower and related facility at one of three alternative locations in the westerly portion of an approximately 627 acre parcel at 72 Ragged Hill Road in Pomfret, Connecticut. Cellco proposes to construct a 150-foot monopole tower at the Site A and Site B locations and a 130-foot tower at the Site C location. Cellco will also install equipment cabinets and a back-up generator on a concrete pad. The tower and related equipment would be located within a 50' x 50' fenced compound. Access to any of the three alternative facility locations would extend from Swedetown Road. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day of the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower at each of the three (3) alternative tower locations. Interested parties and residents of the Towns of Pomfret, Eastford and Woodstock are invited to review the Application during normal business hours on or after July 10, 2018, at any of the following offices:
