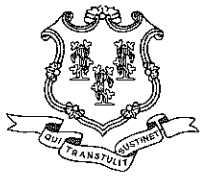

### Supplemental Hearing Notice

The Connecticut Siting Council has previously published a notice for a public hearing to be held at Waterford Town Hall, Auditorium, 15 Rope Ferry Road, Waterford, Connecticut on December 20, 2012 beginning at 2:00 p.m. on an application from Dominion Nuclear Connecticut, Inc., and continuing thereafter as necessary. The applicant submitted an addendum to the application pursuant to Connecticut General Statutes §4-181a (b) to modify the Decision and Order in Docket No. 265 to install concrete pads large enough to accommodate 135 horizontal storage modules, to make drainage improvements and to widen areas for loading operations within the existing Independent Spent Fuel Storage Installation based on changed conditions. The changed conditions include, but are not limited to, considerations and recommendations of the U.S. Department of Energy regarding scientific and technical options available for storage, processing and disposal of spent nuclear fuel.

Pursuant to Connecticut General Statutes § 4-181a (b), the Council will determine if the changed conditions related to the existing Independent Spent Fuel Storage Installation justify a modification of the Decision and Order in Docket 265.
