During the month of May, we have celebrated **National Foster Care Month**. Events statewide afforded us the opportunity to give thanks and show appreciation to you - our foster and adoptive families!

In my travels, I have met with countless individuals to hear their personal stories on why they made the commitment to be licensed. With pride, families recalled when they had their first placement, the bonds they formed with children of all ages and the anticipation of receiving the next call for a child in need.

These moments reinforce why I believe I was called to this work; to strengthen families and protect society's most vulnerable children.

Thank you for loving our children unconditionally. With very little information you open your homes, serving as the calming force during one of the most traumatic times in the life of a child – removal.

Events this month spanned across the entire state. We thank the Connecticut Alliance for Foster and Adoptive Families (CAFAP) for yet again, another great annual conference. Our staff and partners arranged activities such as chalk walks and luncheons to unique events where prospective families spent an entire weekend together to expedite the licensing process. Staff appeared on radio and television to talk about the critical need for families. Dinners were held where inspirational speakers shared how the bonds of a foster and adoptive family changed their lives. We even had a foster parent prom!

Because of you, our children are strengthened, they heal, regain trust and reach their potential when placed with the right family at the right time. Most impressive are those families who partner with the birth parents of the children in their care. What a wonderful message for a child to know the adults in their life accept each other and are joined together- because of them.

Perhaps there is no greater story which exemplifies the power and impact of our families as the one highlighting Ms. Tiffany Strain. During a recent press conference, Ms. Strain spoke of spending a large part of her life in foster care and residential facilities, eventually having a family of her own. When difficult times ensued, two of her children were placed into the foster home of Sarah and Rodney DeMerchant and Ms. Strain's youngest child was placed with Jacquelyn and Rodney Diggs, both DCF employees. Jacquelyn was actually the social worker on Ms. Strain's case when she was placed into foster care. With the foster parents standing by her side, Ms. Strain credited her relationship with these families for strengthening her and giving her confidence - leading to reunification.
