I make the following statement, without fear, threat or promise. I have been advised that any statement(s) made herein which I do not believe to be true, and which statement is intended to mislead a public servant in the performance of his / her official function, is a crime under C.G.S. section 53a-157b and is punishable by law. § 53a-157b

On May 15, 2017, I was working the C shift as car Amber 23 with my partner Officer Mario Pecirep. Officer Pecirep was the driver of Amber 23 and I was the passenger. We heard over Channel 1 that a Gang Task Force Officer (Officer Borrico) called out that he was following a blue Subaru Forester. The blue Subaru Forester was a motor vehicle that matched the description of a stolen car taken earlier that day. Officer Borrico was operating an unmarked police car. Officer Borrico said over Channel 1 that he was following the Subaru on Laurel Avenue heading towards Park Avenue. We started to head towards Park Avenue from Washington Avenue. Officer Pecirep made a right hand turn onto Park Avenue to turn left onto Laurel Avenue. As we were making a right hand turn onto Park Avenue, Officer Borrico called over Channel 1 that the blue Subaru Forester made a right turn from Laurel Avenue onto Park Avenue. This is when I noticed a blue Subaru Forester traveling the opposite direction of my patrol car on Park Avenue. Officer Pecirep made a U-Turn around the island at the intersection of Park Avenue and Laurel Avenue and started to follow the blue Subaru Forester. The blue Subaru Forester made a left hand turn onto Washington Avenue, which Officer Borrico called out over Channel 1. Behind the blue Subaru Forester was a blue pick-up truck. My patrol car was at a safe distance behind the blue pick-up. At this time, I witnessed the blue Subaru Forester make a right hand turn into the Walgreens parking lot. At this time, the blue pick-up truck, that was between me and the blue Subaru Forester, pulled over towards the curb just before the entrance to the Walgreens parking lot. I heard Officer Borrico state over Channel 1 "GO AROUND ME, GO AROUND ME." At this point, Patrol Officer Pecirep drove our marked police cruiser around the blue pick-up truck and made a right hand turn into the Walgreens parking lot.
