ON 05/09/2017 AT APPROXIMATELY 4:30 PM, MY WIFE AND I ALONG WITH
WENT TO 5 STAR PIZZA FOR DINNER. WE WERE SITTING IN OUR CAR ON FAIRFIELD AVE IN FRONT OF THE 5 STAR WAITING FOR OUR PIZZA. I WAS PARKED FACING NORTH I HEARD VEHICLE ENGINES AT HIGH RPM'S COMING IN OUR DIRECTION. I SAW A BLUE/GRAY COLORED CAR TRAVELING FROM STATE STREET TOWARDS FAIRFIELD AVE ON PARK AVE TURN ONTO FAIRFIELD AVE AND TRAVEL IN THE WRONG DIRECTION. THE BLUE/GRAY CAR WAS BEING CHASSED BY BRIDGEPORT POLICE CARS.
THE CAR BEING CHASSED GOT CUT OFF AND STOPPED BECAUSE OF THE ONCOMING TRAFFIC. I SAW A BRIDGEPORT CAR (POLICE CAR) CUT THROUGH THE WALGREEN'S PARKING LOT. I THINK IT WAS A WHITE VAN THAT CUT OFF THE CAR BEING CHASSED.
I THEN HEARD A LOT OF YELLING AND SCREAMING. THE POLICE OFFICERS WERE YELLING STOP AND GET OUT OF THE VEHICLE NUMEROUS TIMES. THE POLICE HAD THEIR GUNS OUT. I NEVER SAW THE DRIVER OF THE BLUE/GRAY COLORED CAR.

I then HEARD 5 GUN SHOTS, (2 GUN SHOTS FOLLOWED BY 3 GUN SHOTS. I DID NOT KNOW WHO WAS SHOOTING AND ONLY HEARD THE GUN SHOTS. AFTER MY WIFE AND I HEARD THE SHOTS, WE TOOK INTO THE RESTAURANT.

APPROXIMATELY 15 MINUTES LATER I WENT OUTSIDE AND SAW AMBULANCES AND A POLICE OFFICER BEING TAKEN AWAY ON A STRETCHER.

I COULD NEVER SEE WHO WAS IN THE BLUE/GRAY CAR BECAUSE THE POLICE HAD IT SURROUNDED.

I WENT BACK INTO THE RESTAURANT WHERE MY FAMILY AND I ATE OUR MEAL. MY WIFE WAS VERY UPSET AND ABOUT 45 MINUTES LATER WE LEFT. I WENT TO THE BRIDGEPORT POLICE DEPARTMENT TO REPORT WHAT I SAW. I GAVE THEM MY NAME AND NUMBER.

MY WIFE TOLD ME THAT SHE HAD SEEN THE OFFICER BY THE WALGREENS WITH HIS GUN OUT BUT NEVER SAW ANYONE SHOOT. SHE ONLY HEARD THE GUN SHOTS.

ONCE THE CAR BEING RANSED GOT CUT OFF, I LOST SIGHT OF IT BECAUSE MY VIEW WAS BLOCKED BY THE OTHER CARS ON THE STREET. I LOOKED LIKE IT WAS MOVING BACK IN A FORTH TO GET AROUND THE TRAFFIC.
