statement ---> See attached for additional details. The following narrative is only a brief summary of the information obtained:

On 05/10/2017 at approximately 1100 hours, arrived at the scene of an Officer-Involved Shooting incident that had occurred the day prior on Fairfield Avenue. indicated she simply wanted to pay her respects as a young male involved in the incident had died and a small "vigil" had been set up community members to commemorate him. As approached the area, she observed two (2) Puerto Rican women standing by the vigil set up at the base of a light pole on Fairfield Avenue by Walgreens. One (1) of the women was crying as she used a mop with some "liquid" to clean up the blood related to the incident. The woman was so visibly upset that offered to mop for her. As started mopping, what she described to be a "fragment" or "bullet fragment", "flung away" from the mop head. immediately stopped and called the Bridgeport Police Department to report what she had found. then put a piece of plastic over the fragment and placed two (2) small stones on top of the plastic to keep it from moving. reported no one, including her, touched the fragment. When the police arrived, showed them what she found and then remained in the area in case more information was needed.

**\*\*NOTE:** was given the option of writing out her own statement or having this Detective reduce it to written form. opted for the latter and dictated her statement, which was then transcribed by this Detective. Upon completion, carefully reviewed the document for accuracy and content. indicated the entire statement was true to the best of her knowledge and belief. At which point, this Detective administered the oath and signed the one (1) page statement.
