With Sadness



Historic Preservation & Opportunity Zones

We have an update on recent legislation that was signed into law by Governor Lamont during the recent legislative session. Senate Bill 570 (Public Act 19-54): An Act Concerning Opportunity Zones repealed C.G.S. Section 10-416c, the Historic Rehabilitation Tax Credit Program, and replaced with a nearly identical statute except the program now allows 30% in tax credits on qualifying



expenditures for projects located within opportunity zones. Additionally, the rating criteria for evaluating projects seeking a tax credit reservation shall give priority to applicants rehabilitating historic structures in opportunity zones.

The SHPO will continue to review applications on a rolling basis, but has set aside \$12 million of the \$31.7 million annual allocation for rehabilitation projects in Opportunity Zones. More details

electric traction system in

significant for its contribution to
area transportation as well as for its
association with early twentieth
century powerhouse design.
