



Pre-Disaster Mitigation (PDM) FY 2019



The FY 2019 Pre-Disaster Mitigation (PDM) program provides funds for projects which reduce the overall risk to population and structures from future hazard events, while also reducing the reliance on federal funding from future disasters

Sub-Applications are due to the State in eGrants no later than November 26, 2019.

Eligible Sub-Applicants

- State and Local Governmental Agencies
 - Indian Tribal Governments
- *Local governments are eligible Sub-applicants and can sponsor applications on behalf of homeowners to submit to the Applicant**

Cost Share Breakdown by Property Type (Percentage of Federal/Non-Federal Share)

- Project selection is a nationally competitive basis once the state set aside has been reached
- 75/25

SUB-APPLICANTS MUST HAVE A FEMA APPROVED MITIGATION PLAN BY JANUARY 30, 2020 TO BE ELIGIBLE TO APPLY FOR PROJECT FUNDING

Eligible Federal Activities and 2019 Priorities are as follows:

- **State/Tribal Set-aside** mitigation activities based on the statutory allocation of the fiscal year
- **Advance Assistance** to develop mitigation strategies and obtain data to prioritize, select, and develop community mitigation projects for future funding
- **Resilient Infrastructure** projects including but not limited to:
 - ⇒ Infrastructure protective measures
 - ⇒ Utility protective measures
 - ⇒ Water and sanitary sewer system protective measures
 - ⇒ Localized flood control to protect critical facilities
- **Other Traditional PDM Projects** including but not limited to mitigation planning, mitigation projects, generators for critical facilities, etc.

Projects will be ranked in the following order:

Priority #1: State/Tribal Set-aside

Priority #2: Advance Assistance

Priority #3: Resilient Infrastructure

Priority #4: Traditional Mitigation Projects

Current mitigation plans are not required for applicants and sub-applicants submitting planning sub-applications to develop a new mitigation plan or to update a mitigation plan

All projects must be cost-effective using FEMA's Benefit Cost Analysis Software or Pre-Calculated Benefits Projects will be ranked within their category by Benefit Cost Ratio. FEMA will accept version 5.3 or newer as the only versions as documentation for demonstrating cost effectiveness.
