	You are an attorney-at-law representing an eligible party, approved state or federal agency, or a member of an incorporated genealogical society authorized to conduct business in the State of Connecticut (see the
	Connecticut State Library for more information)
	The birth record is at least 100 years old
•	uesting a birth certificate for someone other than yourself or your child, you will need to submit proof relationship to the person whose birth certificate you are requesting. For example: If you are requesting the birth certificate of your parent, you must submit a copy of your own birth certificate in order to prove the parent/ child relationship. If you have had your name legally changed by a court decree and your birth certificate does not reflect your new name, you must submit a copy of the court order verifying the legal name change.
