The contract between Connecticut Association for Community Action, Inc. (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and approved the office of the Attorney General on 02/07/2014 is hereby further amended as follows:

- 1. The funding of the contract is increased in the amount of \$20,415.00, and the total contract award is changed from \$1,036,926.00 to \$1,057,341.00. This increase is due to the federal increase to the annual allocation for each budget year.
- 2. The budget on page 8 of the original contract shall be deleted and replaced in its entirety by the budget on page 2 of this amendment
- 3. The Agency address on Page 1 of the original contract shall be changed from 25 Sigourney Street, Hartford, CT 06106 to 55 Farmington Avenue, Hartford, CT 06105.

All terms and conditions of the original contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.
