The contract between Junta for Progressive Action, Inc. ("Contractor") and the Connecticut Department of Social Services ("Department"), which was last executed by the parties and approved by the Office of the Attorney General on 10/21/2014, and previously amended on 10/21/2015 and 10/31/2016 is hereby further amended as follows:

- 1. The term of the contract is extended for an additional one (1) year and the end date of the contract is changed from 6/30/17 to 6/30/18.
- 2. The total maximum amount payable under the contract has increased by \$119,881 from \$390,787 to \$510,668 to provide funding for the extended term of the contract.
- 3. DSS contract/contact person on page 1 of the original contract shall be deleted and replaced as follows: Donna LoCurto at (860) 424-5323.
- 4. For the period 7/1/17 through 6/30/18, Part I, Section J. labeled BUDGET AND PAYMENT PROVISIONS, subsection 1 of this contract and Amendments thereof, shall be deleted and replaced with the following:
