The contract between the University of Massachusetts ("Contractor") and the Connecticut Department of Social Services ("Agency" or "Department"), which was last executed by the parties and approved of the Office of the Attorney General on 9/14/2015.

- 1. The term of the contract is **extended** twelve (12) months and the end date of the contract is changed from 6 /30 /16 to 6 /30 /17.
- 2. The total maximum amount payable under this contract is increased in the amount of \$233,722.00 and the total contract award is changed from \$1,122,481.00 to \$1,356,203.00.
- 3. In addition to the consultation services already being provided under the original contract as amended, the Contractor shall work with DSS to design and develop a web based cost report system for the Connecticut School Based Child Health program for implementation in January 2017.
- 4. All terms and conditions of the original contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.




