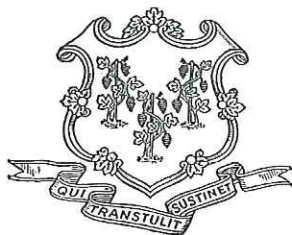

CONTRACT AMENDMENT

The contract between **Almada Lodge Times Farm Camp Corporation** (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and signed by the Office of the Attorney General on 10/10/2014, is hereby amended as follows:

Bond Commission Approval: Public Act #607, 1979 As Amended, Section 21(b)(6)(B) page 52, Item No. 39 (Revised) on January 12, 2015

1. The amount of the contract is increased by \$997,000 from \$591,367 for a total amount of \$1,588,367 as a result of Bond Commission Approval on January 12, 2015 for improvements and renovations to accommodate accessibility to all children at The Channel 3 Kids Camp in Andover.
2. The funds will be utilized for the following:
 - a. Construction of fully accessible pool/bath house
 - b. Completion of fully accessible playground
 - c. Paving of roadways and pathways to ensure total accessibility
 - d. Completion of fully accessible basketball court
3. The budget on page 4 of the original Bond Fund shall be deleted and replaced in its entirety by the budget on page 2 of this amendment
4. Page 3 of this amendment includes information pertaining to this new addition to the contract in addition to that provided on page 5 of the original contract

All terms and conditions of the original contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.




