

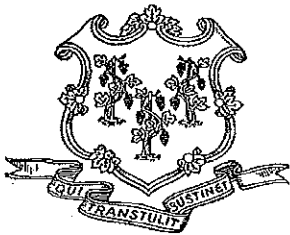

The contract between Ability Beyond Disability ("Contractor") and the Connecticut Department of Social Services ("Agency"), which was last executed by the parties on July 3, 2014 is hereby further amended as follows:

1. The total maximum amount payable under this contract has increased by \$397,083 from \$1,149,690 to \$1,546,773. This increase is to continue services for two (2) years.
2. The term of the contract is extended two (2) years and the end date of the contract is changed from 6/30/16 to 6/30/18.
3. The budget on page 2 of amendment 1 shall be deleted and replaced in its entirety by the budget on page 2 of this amendment.

**All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.**
