The contract between The Community Action Committee of Danbury, Inc. (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and signed by the Office of the Attorney General on 04/09/14, is hereby amended as follows:

- 1. The total maximum amount payable under this contract is increased by \$62,747 from \$118,823 to \$181,570. This increase is to continue to provide HHD services to the Stamford and Norwalk service areas located at 5 River Street, Norwalk and Stamford library located on Hope Street.
- 2. The budget on page 2 of amendment A1 is deleted and replaced in its entirety by the budgets on pages 2-4 of this amendment.

This document constitutes an amendment to the above numbered contract. All provisions of that contract, except those explicitly changed above by this amendment, shall remain in full force and effect.
