Failure to apply to the Department of Emergency Services and Public Protection for a certificate of possession for such firearm within ninety days of such purchase, pursuant to section 53-202d (a)(2)(A) of the Connecticut General Statutes, shall constitute the unlawful possession of an assault weapon. 3. Possession of a firearm for those who have been issued a certificate of possession is subject to the conditions outlined in section 53-202d(f) of the Connecticut General Statutes. 4. The certificate of possession is granted pursuant to section 53-202d of the Connecticut General Statutes to be used by the purchaser primarily for use in target shooting practice and events sanctioned by the International Olympic Committee and USA Shooting, or any subsequent corresponding governing board for international shooting competition in the United States. If, at any point, the firearm is no longer being used primarily for such target shooting practice and events, the owner shall notify the Department of Emergency Services and Public Protection.
