Please find below important new information regarding DDaP implementation:



1. Changes in DDaP Release 2.0 :

- **File Management** - Files with multiple services for the same day(s) will now display an alert icon in the File Management grid to alert you that a potential aggregation issue exists.

When you place your mouse over yellow triangular icon, the message "Duplicate Service(s) in File" is displayed.

2. New Levels of Care - have been added to DDaP.

- LOC Type = Inpatient Services; LOC Mode = Acute Psychiatric - Intermediate
- LOC Type = Residential Services; LOC Mode = SA Intensive Residential - Enhanced
- LOC Type = Residential Services; LOC Mode = Transitional
- LOC Type = Housing Services; LOC Mode = Housing Coordination

3. Training - The “DDaP Electronic File ERROR Corrections Training” class covers how to analyze and correct errors that display after submitting a file. This class is recommended for anyone submitting either the DMHAS Standard or Services-Only file that is having difficulties troubleshooting and correcting errors. The offerings are:
